



## SAVE WESTERNPORT (SWP)– No AGL gas terminal for Crib Point 1st June 2018 Issue #1

Welcome to our first update in newsletter style. Since our 'Save Westernport - No AGL Gas' public meeting on 8 May attended by over 120 residents, it's been a breathtakingly busy time. We've submitted the first batch of signed petitions, started an online Change.org petition, the website draft is live, every week there has been articles and letters in local papers, stints on ABC Radio Melbourne..... and more! So, without any further ramblings here's the news:

**Crib Point Action Group (CPAG):** SWP members were invited to attend the monthly CPAG meeting. It was great to get together and share our ideas to achieve the residents' goals for Crib Point. SWP benefitted from learning from the experienced CPAG team and gaining deeper insight into the history of the Crib Point community vision for the future. And guess what? It doesn't include a floating gas terminal! A CPAG member may join the SWP steering committee if they can fit it in. Either way, we look forward to working together to support the future of Crib Point.

**Jeff Nottle – Preserve Westernport:** Jeff kindly gave up some of his time to come and talk to some of us about the Preserve Westernport Stop the Port campaign. SWP absorbed an extraordinary amount of information in a couple of hours from strategy to fundraising to printing and editing and so on. We really appreciated having access to hard-earned experience from a three-and-a-half-year battle to stop the container port going ahead.

**On 28 May, AGL advised that they have now placed the last of their draft assessments on line and will receive comments from the public until 15 June. They intend to lodge their referral with the Hon Richard Wynne, State Planning Minister late June. **Delegation to Ministers** – Neale Burgess has already informed the shadow ministers about the horror gas ship and we persist in trying to set up a meeting with the relevant state government departments to express our concerns. Frankston Labour MP, Paul Edbrooke presented our information to Hon Lily D'Ambrosio (Minister for the Energy, Environment and Climate Change). SWP emailed a letter on 24 May formally requesting a meeting with Ms D'Ambrosio.

The same week, Greg Hunt basically gave the same reply when he was contacted by another worried local. Their advice to us is pretty much summed up in this letter to the editor published in the **Western Port News Letters 29<sup>th</sup> May 2018** -

### 'Go to websites for answers' – MP, CEO

Greg Hunt's advice to Sylvia Simon and the community to "engage in AGL's feedback process via Jay Gleeson of AGL" left me open-mouthed. The icing on the cake was receiving the same brush off from Mornington Peninsula Shire Council. Last Tuesday night, the 22<sup>nd</sup> May, four questions regarding the proposed floating gas terminal at Crib Point were asked at the public meeting held in Rosebud. The response? CEO Carl Cowie took the questions and announced that AGL's community engagement website was the best avenue. One of the questions touched on the Kawasaki coal to hydrogen project which will ship out of Hastings. Same gob-smacking advice - refer to the Hydrogen Energy Supply Chain website. Funny. I didn't realize that AGL and Kawasaki were looking after constituents' concerns. Nor did I comprehend that they were now representing residents. Perhaps they would like to receive my next rates payment. We should be very deeply concerned that our paid representatives feel it is acceptable to tell us to engage with corporations whose sole strategic goal is profit.
